- Vendors are requested to make **PAYMENT THROUGH ONLINE MODE ONLY**. For any other mode of payment cheque/draft, kindly contact DOS Secretariat [secretary@dosonline.org](mailto:secretary@dosonline.org). The time of transfer of money to DOS account will be considered for stall allotment in case of payment method other than online.
- \*Stall charges are inclusive of 18% GST. In case of TDS, the same will be only on the basic amount of stall Charges and not on GST amount at all because the GST Amount is payable to the Government Account.
- GST on Tariff rates is applicable on reverse charge i.e. borne by service recipient if the service recipient is a body corporate or partnership firm vide entry no. 4 of Notification No. 13/2017 dtd.28/06/2017 otherwise GST @ 18% will be charged extra.
- The amount of GST is credited to the Government Account and therefore, there will be no refund at all of GST Amount.
- The Live Surgery Slots, Wet Laboratory Area, Exhibition Area, Special Exhibition Stalls, Faculty Dinner, DOS Quiz, and Exhibition Regular Stalls which will be allotted on **First Come First Serve Basis**. We will confirm the allotment of sponsorship options and exhibition booths on receiving full payment ONLY. The exhibitors desirous of booking more than one stall will be allotted adjoining stall(s) subject to availability only.
- Partial deposit of stall charges is not permissible**. The Exhibitor is required to pay full charges including GST for the number of stalls to be booked. **PLEASE NOTE that the stall allotment will be done on priority to those whose full amount of stall charges has been remitted.**
- TDS Certificate must be submitted before the month of June. In the event of non-submission of the TDS Certificate, we will have the right to deduct the TDS amount from the next payment received from the company.

- Please note that no refund of payment will be done once the stalls have been booked and payment has been made. **No Refund will be made for Non participation for any reason.**
