- The exhibitors are requested to send the duly completed and signed form, along with the payment by **RTGS/ NEFT / Demand Draft / Cheque/ online bank transfer** to the DOS Secretariat.
- All Demand Drafts / Cheque / Online bank transfer should be made in the favor of **“Delhi Ophthalmological Society”**, payable at **New Delhi**.
- All Payment should be made in the favor of **“Delhi Ophthalmological Society”**, payable at **New Delhi**.
